Foundation raises over \$150,000 at Annual Gala & Auction!

The Custer County Foundation held its 14th Annual Gala & Auction on Saturday, December 8th at the One Box Convention Center in Broken Bow. The evening was deemed a success, raising \$150,000! The Foundation sincerely appreciates the generosity of the many businesses and individuals throughout Custer County. THANK YOU for making it possible to have a successful event!

As guests arrived they had the opportunity to purchase keys for \$10 each. After all keys were sold, guests tried to unlock one of three gift boxes containing cash prizes donated by Muddy Creek Ag (\$250), Arrow Aviation, Inc. (\$500), and Edward Jones, Gateway Motors, and Palmer Monument(\$1,000).

Ginger Correll was the lucky winner of the stunning 14K white gold diamond necklace donated by Sargent Irrigation Company.



Below is a list of the new scholarships available. Thank you to the businesses and individuals who recently established these scholarships.

EZ IT Solutions Information Technology Scholarship, \$1,000

- -Available to Custer County high school seniors or Custer County high school graduates currently enrolled in college.
- -Must be pursuing an undergraduate degree or technical degree in Information Technology or related field.
- -On a page separate from Biographical Narrative, please address the following two questions: (1) Why are you pursuing a degree in the Information Technology field? (2) What have you done to prepare yourself for the Information Technology field?

Nebraska State Bank Scholarship, \$1,000

- -Must be a senior at a Nebraska high school.
- -Student, parent, or grandparent must be a customer of NSB and student must state in application the name of the customer and their relationship (parent or grandparent).

Nebraska State Bank Hometown Scholarship, \$1,000

- -Must be a senior at a Custer County high school.
- -Must write a 500 word essay on why you plan to return to Custer County.

Nebraska State Bank Business Scholarship, \$1,000

- -Must be a senior at a Nebraska high school or must have graduated from a Nebraska high school.
- -Preference given to students in the following degree areas: Finance, Accounting, Business Administration, or Business Management.

Nebraska State Bank Youth Leadership Custer County Scholarship, \$1,000

- -Must be a current or past participant in Youth Leadership Custer County.
- -Must write an essay on how you benefited by participating in Youth Leadership Custer County.
- -Letter of recommendation from someone you worked with during YLCC
- -High school and college students are eligible.

Nebraska State Bank College Scholarship, \$1,000

- -Must have graduated from a Nebraska high school.
- -Must be a college student entering their second year or above.
- -Must include in biographical narrative how student has taken a leadership role in college.

Tiffany Theater Scholarship, \$500

- -Must be a current or former employee at the Tiffany Theater.
- -Student can be a high school senior or currently enrolled in college.
- -Employee must have been in good standing.
- -Must have been employed at Tiffany Theater for at least one year.

Marvin Payne Memorial Scholarship, \$500

-Must be a senior at Broken Bow High School.
